## **Bromley Liberal Democrats 100 Club Rules**

(v1.2 dated 31 Jan 19)

Object: The object of the Bromley Liberal Democrats 100 Club (hereafter called the Club) is to raise money for the Bromley Borough Liberal Democrat Party (hereafter called the Party). All profits will be paid into the funds as directed by the Managing Committee.

Administration: The Club will be administered by a Managing Committee\* (hereafter called the Committee) comprising:

- The 100 Club Organiser to be nominated by the Executive Committee of the Party.
- The Party Treasurer
- Up to three members of the Party to be nominated by the Executive Committee

The Committee are empowered to operate a bank account utilising one or more authorised signatories. All withdrawals shall be authorised by any of the authorised signatories.

All decisions made by a majority of the Committee shall be considered final. The quorum shall be three members.

Membership is open to any person over 18 and is obtained by purchasing shares at £5 each per month, after completing and returning to the Committee the appropriate Bankers Order/Giro Standing Order. Membership is valid from the operative date of that order. Subscriptions are payable every month

Each share will be individually numbered and will be acknowledged by the issue of a share number.

A draw will be made every month with a 1st, 2nd and 3rd prize.

Prizes will depend upon the number of fully paid up shares as follows:

The prizes will total 50% of the of the prior months income. This will be apportioned as:

First prize: 25%, Second prize: 15%, Third prize: 10%

The Draw. The draw will be made at Executive Committee meetings or at other party activities, monthly or bimonthly as far as is practicable. All members will be informed of the result of the previous twelve monthly draws by the 100 Club Organiser at yearly intervals. Any member may however obtain the results on request at any time after the draw. The winning share will be selected by drawing share numbers at random. The method of draw will be decided by the Committee but all members shall have the right to be present.

If a prize winner cannot be contacted, the winnings will be forfeited after a period of 6 months.

Closure: The Club will be closed as directed by a quorate meeting of the Executive or when the total number of subscribed shares falls below 20 for a period of three months. In this event all subscriptions paid after the last draw will be repaid by the Party Treasurer. Any accumulated profit remaining at that time will be transferred to the Party Election Funds.
